§139.053 – Payment of Property Taxes

Oversight assumes this legislation allows townships the option to pass an order or ordinance to allow taxpayers the option to pay any part of their real and personal property taxes on an annual, semiannual, or quarterly basis. Oversight assumes no fiscal impact from this proposal.

Oversight only reflects the responses received from state agencies and political subdivisions; however, counties, county collectors and county treasurers were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
