FISCAL ANALYSIS

ASSUMPTION

§50.333 – Removal of Prosecuting Attorney and Sheriff from the County Salary Commission

Officials from the **Missouri Office of Prosecution Services, Office of the State Courts Administrator** and the **Phelps County Sheriff’s Office** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other counties, circuit clerks, county prosecutors and sheriffs were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
