FISCAL ANALYSIS

ASSUMPTION

§§115.133 and 561.026 - Restores Voting Rights to Individuals on Probation and Parole

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials from the **Department of Corrections (DOC)** assume there is no fiscal impact on their organization.

Upon further inquiry, DOC stated in FY25, they averaged 53,000 offenders under supervision. Therefore, **Oversight** assumes there could be an increase in registered voters.

Oversight notes that the Office of the Secretary of State and Department of Corrections have each stated the proposal would not have a material fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Platte County Board of Elections, St. Louis City Board of Elections, Jackson County Election Board and St. Louis County Board of Elections** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight does not have information to the contrary and therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
