ASSUMPTION

§§71.012 & 71.015 – Annexation Procedures for Cities

Officials from the **Department of Natural Resources, Office of the Secretary of State, Platte County Board of Elections, St. Louis County Board of Elections, City of Kansas City, St. Louis City Assessor’s Office, Kansas City Police Department, Branson Police Department, Howard County C-PWSD #1, Metropolitan St. Louis Sewer District, South River Drainage District** and the **Wayne County PWSD #2** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation, HCS for HB 2330 (2026), officials from the **Missouri Department of Transportation, Office of the State Courts Administrator, City of Osceola, Jackson County Election Board, Kansas City Election Board, Osceola Water/Wastewater District, St. Louis City Board of Elections, and the St. Louis County Police Department** each assumed the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **City of St. Joseph** did not respond to **Oversight’s** request for fiscal impact for this proposal.

Oversight assumes this proposal allows the City of St. Joseph to annex an airport that is outside the boundaries of the City and is owned and operated by the City regardless of whether the boundaries of the airport are contiguous and compact to the existing corporate limits of the City. Oversight assumes no fiscal impact from this proposal.

Oversight states §71.014 in current law provides an additional annexation procedure for cities in certain counties using a petition process rather than a vote of the residents of the annexed area. This proposal would repeal this section and is not anticipated to have a fiscal impact.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other other cities, local election authorities, counties, county assessors, county circuit clerks, police departments, fire protection districts and utility districts were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
