**§§340.200 - 340.295 - Livestock Reproductive Specialists**

Officials from the **Department of Commerce and Insurance (DCI)** assume the cost of the three-member Certification Examination Committee can be absorbed. There is no language in the bill regarding per diem or cost reimbursement to the committee members. Should the cost be more than anticipated, the division would request an increase to their FTE and/or appropriations as appropriate through the budget process.

**Oversight** notes the above-mentioned agency has stated the cost of proposal could be absorbed. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.
