**§167.019 – School Placement for Students in Foster Care**

Officials from the **Department of Elementary and Secondary Education** and **Department of Social Services** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for this agency.

**Oversight** notes this proposal extends the distance for foster children who are also students to remain in their domicile school district when their foster care placement changes. Oversight does not expect this this proposal to have an additional fiscal impact on school districts.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
