AN ACT

To amend chapter 191, RSMo, by adding thereto one new section relating to a sickle cell standing committee.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 191, RSMo, is amended by adding thereto one new section, to be
2 known as section 191.117, to read as follows:

3 **191.117. 1. This section shall be known and may be cited as the "Lori Zena**
4 **Baker Act".**

5 **2. There is hereby established in the department of health and senior services a**
6 **"Sickle Cell Standing Committee" as a subcommittee of the Missouri genetic advisory**
7 **committee. The committee shall consist of the following members:**

8 **(1) One member who is a licensed physician with experience in the diagnosis and**
9 **treatment of sickle cell disease and who shall serve as chair of the committee;**

10 **(2) One member who has sickle cell disease or is a family member of a person**
11 **with sickle cell disease;**

12 **(3) One member with expertise in sickle cell disease research;**

13 **(4) One member from a leading sickle cell disease organization;**

14 **(5) One member with expertise in minority health; and**

15 **(6) One member from each hemoglobinopathy center that contracts with the**
16 **department.**

17 **3. The members of the committee shall be appointed by the director of the**
18 **department of health and senior services. Members shall serve on the committee**
19 **without compensation or reimbursement for expenses incurred.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in bold-face type in the above bill is proposed language.

18 **4. The committee shall:**

19 **(1) Assess the impact of sickle cell disease on urban communities in the state of**
20 **Missouri;**

21 **(2) Examine the existing services and resources addressing the needs of persons**
22 **with sickle cell disease; and**

23 **(3) Develop recommendations to provide educational services to schools on the**
24 **traits of sickle cell disease and its effects.**

25 **5. The committee shall include an examination of the following in its assessment**
26 **and recommendations required under subsection 4 of this section:**

27 **(1) Trends in state sickle cell disease populations and their needs including, but**
28 **not limited to, the state's role in providing assistance;**

29 **(2) Existing services and resources; and**

30 **(3) Needed state policies or responses including, but not limited to, directions for**
31 **the provision of clear and coordinated services and supports to persons living with sickle**
32 **cell disease and strategies to address any identified gaps in services.**

33 **6. The committee shall hold a minimum of one meeting in three urban regions of**
34 **the state to seek public input.**

35 **7. The committee shall submit a report of its findings and any recommendations**
36 **to the general assembly and the governor no later than December 31, 2027.**

37 **8. After December 31, 2027, the committee shall continue to meet at the request**
38 **of the chair and at a minimum of one time annually to continue the study of sickle cell**
39 **disease in this state, to consider the impact of the committee recommendations, and to**
40 **provide an annual supplemental report on the findings to the governor and the general**
41 **assembly.**
