HB 2007, introduced by Representative Deaton, to appropriate money for the expenses, grants, refunds, and distributions of the Department of Economic Development, Department of Commerce and Insurance, Department of Labor and Industrial Relations and the several divisions and programs thereof, to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2026, and ending June 30, 2027.

HB 2008, introduced by Representative Deaton, to appropriate money for the expenses, grants, refunds, and distributions of the Department of Public Safety and Department of National Guard and the several divisions and programs thereof to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2026, and ending June 30, 2027.

HB 2009, introduced by Representative Deaton, to appropriate money for the expenses, grants, refunds, and distributions of the Department of Corrections and the several divisions and programs thereof to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2026, and ending June 30, 2027.

HB 2011, introduced by Representative Deaton, to appropriate money for the expenses, grants, refunds, and distributions of the Department of Social Services, and the several divisions and programs thereof, to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2026, and ending June 30, 2027.

HB 2013, introduced by Representative Deaton, to appropriate money for real property leases, related services, utilities, systems furniture, structural modifications, and related expenses for the several departments of state government and the divisions and programs thereof to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, and to transfer money among certain funds for the period beginning July 1, 2026, and ending June 30, 2027.

HB 2017, introduced by Representative Deaton, to appropriate money for capital improvement and other purposes for the several departments and offices of state government and the several divisions and programs thereof to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri for the period beginning July 1, 2026, and ending June 30, 2027.

THIRD READING OF HOUSE COMPLAINTS

HC 1, relating to House Ethics Complaint No. 25-02, was taken up by Representative Roberts.

Representative Roberts moved that the House of Representatives third read and adopt the report by the Committee on Ethics, dated January 7, 2026.

HOUSE COMPLAINT NO. 1

HOUSE ETHICS COMPLAINT NO. 25-02

In the Matter of Representative Jeremy Dean

WHEREON, the Committee on Ethics, of the Missouri House of Representatives, 103rd General Assembly, pursuant to Rule 8 of the Ethics Committee Rules of Procedure, reports as follows:

1. On September 8, 2025, the committee was referred a complaint filed by a member of the House of Representatives (Complainant) concerning the conduct of Representative Jeremy Dean (Respondent).
2. The complaint stated that on September 4, 2025, during a meeting of the Elections Committee, Complainant received an unsolicited and inappropriate text message from Respondent. Complainant was a member of the Elections Committee and participated in the hearing. Respondent was watching the hearing live from the House of Representatives chamber.
3. The text message was sent at approximately 7:46 pm during the executive session, and at the time, roll call votes were taking place on House Joint Resolution 3. The substance of the message was vulgar and sexual in nature. Minutes later, Respondent sent a second message after watching Complainant's reaction on the live feed of the committee hearing. Complainant was shocked by these messages, which were unprofessional and disruptive to the legislative process.
4. Respondent filed a response acknowledging that he sent the text messages described in the complaint. Respondent stated that he recognized that the messages were inappropriate and unprofessional, and that he regretted sending them. Respondent denied any intent to disrupt the legislative process, intimidate the Complainant, or improperly influence her participation in the committee hearing. Respondent also submitted a copy of a letter he sent to Complainant apologizing for sending the text messages.
5. The rules of procedure define ethical misconduct to include any conduct constituting a legal or moral wrong that materially impairs the member's ability to perform the duties of his or her office or substantially impairs public confidence in the General Assembly.
6. The definition of sexual harassment, found in the House Policy Handbook, includes unwelcome verbal conduct of a sexual nature that has the purpose or effect of substantially interfering with an individual's work performance or creating an intimidating, hostile, or offensive work environment.

7. On September 10, 2025, the committee held a jurisdictional hearing to consider this complaint. The committee, by a vote of 9-0, determined the complaint was in compliance with the rules and that the matter should proceed to a primary hearing.
8. On October 29, 2025, the committee held a primary hearing and received testimony from both Complainant and Respondent.
9. After consideration of the testimony and other evidence, the committee, by a vote of 10-0, determined that the complaint was well founded, that Respondent has committed unethical conduct, and that pursuant to Rule 8(F), Respondent receive a reprimand with the following conditions, including the denial of certain privileges of office:
 - a. Respondent be removed from any committee assignments for the remainder of the 103rd General Assembly;
 - b. Respondent attend additional training in the subject of preventing sexual harassment in the workplace;
 - c. Respondent refrain from any contact with Complainant and maintain physical separation of at least fifty feet from Complainant;
 - d. Respondent be subject to reassignment of seating on the House floor and garage parking space.
10. The committee's decision and recommended sanctions were promptly communicated to Respondent. Pursuant to the rules, Respondent was given fifteen days to object to the recommended sanction. Respondent did not object to the recommendation; therefore, the committee submits this report and recommendation for consideration by the House of Representatives.

NOW THEREFORE, the Committee on Ethics, having given full consideration to this complaint, including hearing the statement to the committee from Respondent, finds that the complaint filed in this matter is well founded and that Respondent committed ethical misconduct and recommends that the House of Representatives reprimand Respondent, Representative Jeremy Dean, for his conduct set forth herein, with the following conditions, including the denial of certain privileges of office:

- a. That Respondent be removed from any committee assignments for the remainder of the 103rd General Assembly;
- b. That Respondent attend additional training in the subject of preventing sexual harassment in the workplace;
- c. That Respondent refrain from any contact with Complainant and maintain physical separation of at least fifty feet from Complainant; and
- d. That Respondent be subject to reassignment of seating on the House floor and garage parking space.
