

HCS HBs 1663, 1607 & 1973 -- PARTICIPATION IN ATHLETICS
COMPETITIONS

SPONSOR: Seitz

COMMITTEE ACTION: Voted "Do Pass with HCS" by the Standing
Committee on Emerging Issues by a vote of 9 to 4.

The following is a summary of the House Committee Substitute for
HBs 1663, 1607, & 1973.

Currently, schools can only allow students to compete in
athletics competitions designated for the student's biological
sex, as indicated on the student's official birth certificate.
Except that female students may participate in athletics
competitions designated for male students if no corresponding
competition for female students is offered.

This provision is set to expire on August 28th, 2027. The bill
removes the expiration date for this language.

This bill is similar to HB 36 and HB 113(2025).

The following is a summary of the public testimony from the
committee hearing. The testimony was based on the introduced
version of the bill.

PROPONENTS: Supporters say that when biological differences
between males and females are ignored by school officials,
women's sports participants suffer greatly. Having two separate
sports teams for boys and girls creates a level playing field and
promotes fairness. Supporters further state that a number of
female athletes have been injured during athletic contests when
biological men participate in those games. Such injuries result
because of the physical differences between male and females, in
terms of bone structure and muscle mass, which in turn gives the
male athletes a tremendous unfair advantage.

Testifying in person for the bill were Representative Seitz;
Liberty Link Missouri; Missouri Catholic Conference; Ella
Percival; and Sierra Smith.

OPPONENTS: Those who oppose the bill say that the central
argument has nothing to do with athletic fairness, but is rather
about a discriminatory policy being leveled against a minority
group. Young people who have transitioned just want to
participate in sports and spend time with friends and classmates.

Opponents further state that this bill sends the clear message that transgender youth do not belong, and that further marginalization will result. Opponents state that the struggle transgender youth have endured in their attempts to compete in certain sports activities is similar to the struggle that biological women suffered before Title IX was passed into law.
