Babies Were Born Alive After Botched Abortions, Denied Medical Care and Tossed Into Buckets
Life News - Sarah Terzo - Jan 19, 2026 - Washington, DC

From the earliest days of legalized abortion in America, babies have been accidentally born alive during abortion procedures.

Several states legalized abortion before the Roe v. Wade Supreme Court decision in 1973. New York was one of them. It legalized abortion in 1970.

A 1972 pro-life book called Respectable Killing: The New Abortion Imperative documented cases in which babies were born alive during abortions in New York and elsewhere. Most of these live births happened as a result of saline and prostaglandin abortions.

Old, Dangerous Abortion Techniques

Saline abortions are carried out by injecting a caustic saline solution into a woman's uterus. The saline solution burns the skin and lungs of the child, slowly poisoning him or her.

Then the woman goes through labor to deliver a dead (or dying) child. Saline abortions caused so many live births and were so dangerous to women that most abortionists stopped doing them several years ago.

Prostaglandin abortions are also done by inducing labor, in this case with prostaglandin drugs, and countless babies survived the procedure.

It was generally believed that these gruesome abortion methods were relics of the past. But a 2021 Live Action News article by Carole Novielli documents that these abortions have been reported as recently as 2020.

Research shows that 121 saline abortions and 68 prostaglandin abortions were committed in New York in 2018.

In 2019, four saline or prostaglandin abortions were done in Missouri and three in Pennsylvania. And in 2020, two saline or prostaglandin abortions were done in Michigan.

Quotes from Eyewitnesses

In 1970, many late-term abortions were carried out in hospitals. In a November 1970 article in Washington Catholic Standard, a nurse at one of these hospitals who assisted in saline abortions wrote that:

Throwing away perfectly formed fetuses [is] revolting... No matter what anyone tells you and no matter what your religious beliefs, it's a physically grotesque thing to work at for eight hours a day.

Another nurse claimed that babies were being born alive during abortion procedures. She said: I couldn't possibly go on ignoring the live fetuses or even putting the dead ones in buckets to be sent to the lab.

She was ordered to ignore the born-alive babies, but in one case, she insisted the child be given

medical care. She explained:

One day, when I came on duty, the nurse going off duty pointed to the table on the other side of the room where the fetuses were placed. It was easy to detect all the way across the room a visibly strong heartbeat.

The other nurse was timid, and she asked me to speak to the doctor. When I pointed it out to him, he said, "For all intents and purposes, it's dead. Leave it there."

I told him I couldn't do it. He could have my job on the line, but I wouldn't do it. This time I was going to take it to the nursery. I knew the fetus would probably die, but I had to give it a chance...

The book *Respectable Killing*, which shared excerpts from the *Washington Catholic Standard*, didn't say whether the child survived, and I was unable to get my hands on the original article.

But it is clear from the nurse's testimony that babies were regularly surviving abortions at this hospital. The same article described how nurses put aborted babies into buckets of formalin solution and sent them to the lab.

The lab wasn't open on weekends, so the bodies piled up until Monday morning.

One nurse was quoted as saying:

You could populate a whole village with the fetuses in cartons lined up on the table on Monday morning.

Despite the use of the scientific (and dehumanizing) term "fetuses," these were tiny babies who had been killed midway through pregnancy.

How Many Babies Were Born Alive?

Respectable Killing cited a December 18, 1970, article in *The Chicago Tribune* that revealed 26 babies had been born alive after abortions in New York City. Only one of the 26 babies, a girl, survived long-term. She found a home with adoptive parents.

A *National Catholic Reporter* article quoted OB/GYN Dr. Robert R Onorato saying he believed the actual number of babies aborted alive was "in the hundreds" since the true figure goes unreported.

Still other sources, according to the book, put the number of babies aborted alive in New York by the end of 1970 at 62.

The Oregon Right to Life Committee documented 33 cases of live births after abortions in the state of Oregon by 1972.

Oregon had only legalized abortions under certain circumstances, but according to author KD Whitehead, abortionists violated the law in many cases without being prosecuted. An article published March 14, 1972, in the *Oregon Journal* had the tagline, "Officials Wink at Laws."

In an April 29, 1971, article, the *Washington Catholic Standard* reported a live birth at the Washington Hospital Center, which at that time was committing 100 abortions a week. Reportedly, the living baby was placed in a refrigerator and expected to die, but was found later by another employee, still alive. The same abortionist delivered a second living baby after an abortion. Only then were the doctor's hospital privileges revoked.

Because D&E abortion (where the baby is dismembered with forceps) is now the most common method of second-trimester abortions instead of saline or other induction methods, live births may be less common today than they were in the 1970s and 80s.

But we don't really know, because most cases are never reported.

There have been many attempts to pass laws protecting babies born alive after abortions and requiring them to receive medical care. They have all been defeated by pro-abortion politicians, usually Democrats.

Tragically, the party that has fought so devotedly to provide help to the poor and disabled, advocating for lifesaving healthcare and SNAP benefits, has a long history of enabling the killing of people who are even more vulnerable – the preborn.

Thus, anyone who is present when a child is born has a moral and/or professional obligation to seek and provide such care. In the event of infanticide by direct action or negligence, such persons ought to be held criminally responsible.

Despite abortion being decriminalized in 1973, we have seen numerous women being subjected to unsafe, unsanitary, and unlawful abortions. They have also been coerced into or received unwanted abortions. Legalizing abortion has not prevented countless complications and/or maternal death from occurring. Thus, these women and their immediate family not only deserve protection from this but also their day in court.

I urge passage of HB 1667.

Thank you, Chairperson Jones and committee, for bringing these bills up for a hearing. I would like to encourage this committee to heartily vote “do pass” on these wonderful pieces of legislation. 
But here in 21st century America there are many who consider babies as less than human, deprived of personhood, and regulated to being nothing more than a clump of cells. Deprived of their inalienable right to life and liberty. Some would go so far as to say that babies are “vermin”, posing health risk to their own mothers. And tragically, they are often seen as not being financially viable. There are children dying not because of their race or ethnic heritage, but simply because of their age or the fact that they are unwanted by their parents.

Though the Romans claimed to be civilized, they were the true barbarians. In the Roman culture if a baby was unwanted, they would simply take them to the dump and allow them to die by “exposure” – the heat of the sun, the cold of the night, the hunger, the rodents . . . the child would soon die of neglect. Thankfully, with the spread of Christianity and its unwavering commitment to the sanctity of all human life, that practice ended and the culture began to find ways to care for these unwanted children. To say that these children that survive an abortion are unwanted and should be discarded is a farce! They may be unwanted by their mother, but there are over 2 million families in the US today who would like to adopt a baby. Rather than killing our children we need to be working on a way to make adoption more accessible.

Finally, let me ask a simple question . . . if we can allow an infant who just survived an attempt to kill it to die, then will it be okay to allow a 6 month old baby to die if they are unwanted? What about a 2 year old – they can be pretty challenging too, you know....or a 13 year old? Man! There are times when every parent has been tempted, right? Or what about an old man sitting before you making some of you uncomfortable by my forthright discussion of the fact that every human life is valuable and is to be

protected with the same passion and vigor and attention as every other human life. Are we going to strive to be better than the Romans, better than our American forefathers, and better than the Nazi's? Are we going to rise above the past evils of humanity, or are we going to join them in their atrocities?

I expect a unanimous vote of "do pass" on HB1667 and 2294.



To Whom It May Concern,

I am writing in strong opposition to any effort to criminalize abortion or roll back protections for reproductive healthcare in the state of Missouri.

This issue is not theoretical for me. I am alive today because I had access to a medically necessary abortion. It was not a choice made lightly, nor was it elective—it was lifesaving healthcare. Had doctors been forced to delay care due to fear of criminal charges, I may not be here to write this letter.

Policies that criminalize abortion do not stop abortion. They stop safe medical care. They force physicians to hesitate in emergencies, place politics between patients and doctors, and endanger women's lives. History and medical evidence show clearly that when abortion is restricted or criminalized, maternal mortality rises. Women suffer. Women die.

Missouri voters are actively fighting to protect reproductive rights through the democratic process, including constitutional amendments. Attempts to override the will of the people or to impose criminal penalties on patients and healthcare providers undermine both democracy and basic human rights.

No one should face arrest, prosecution, or imprisonment for receiving medical care. No doctor should fear prison for doing their job. And no family should lose a loved one because lawmakers chose ideology over evidence-based medicine.

Abortion is healthcare. Emergency abortion care is lifesaving. Criminalizing it will have devastating consequences—especially for women with pregnancy complications, women with limited access to care, and women in rural and underserved communities.





Chair and Members of the Committee,

Thank you for the opportunity to testify in opposition to HB 1667 and HB 2294. Planned Parenthood Great Rivers Action represents thousands of Missourians who believe deeply in patient safety, medical integrity, and the principle that health care decisions are best made by patients and medical professionals, not politicians or prosecutors.

Broadly, this bill represents troubling government overreach and interference with patients' health care decisions — based not on clear medical standards, but on politically-defined mandates. It requires automatic hospital transport regardless of medical appropriateness, ignoring widely accepted neonatal medical standards and family-centered care. These mandates erode trust between patients and providers, and push qualified clinicians out of Missouri at a time when our state already faces serious health care workforce shortages. These provisions do not improve health outcomes, they increase suffering for Missouri families and undermine compassionate, evidence-based medicine.

Missouri law already requires that any infant born alive is a legal person entitled to care and protection. Physicians already have ethical, professional, and legal duties to provide appropriate medical care to any newborn. These bills do not address the real challenges confronting families and their health care providers.


In addition, HB 1667 and HB 2294 invite the criminal justice system into exam rooms and delivery rooms, expand civil lawsuits with sweeping damages, and encourage surveillance and reporting among health care workers. These bills dramatically expand criminal and civil liability for health care providers, imposing severe penalties, including first-degree murder charges, and mandatory reporting requirements that would force providers to practice defensive medicine under threat of prison, even when a pregnancy involves catastrophic fetal anomalies or when medical judgment calls for palliative, not invasive, care.

When Missouri families and their physicians are already faced with the devastation of losing a fetus to fatal anomalies, they shouldn't have to fear prosecution or wait for an opinion from an attorney before making the best decision for their health and well-being. Elevating lawmakers' judgment over that of trained medical professionals in an especially complex medical situation — and a deeply personal moment for families — is dangerous for families.

Missourians across the political spectrum agree on some basic principles: laws should solve real problems, respect professional expertise, and avoid unintended consequences. HB 1667 and HB 2294 fail all three tests. They are redundant, punitive, and dangerously vague, while offering no meaningful improvement to patient safety.

Planned Parenthood Great Rivers Action urges you to reject HB 1667 and HB 2294 and instead focus on policies that genuinely support Missouri families — policies that strengthen maternal and infant

health, respect medical judgment, and keep the government from interfering in deeply personal health care decisions.





I am submitting testimony today, urging you to keep abortion legal in the state, because I am fearful of what could happen to me if I get pregnant, wind up needing medical attention in the form of an abortion, and can't get it because of legislation. It is proven that states with abortion bans have more instances of maternal deaths because doctors have to spend precious time deciding if it's legal for them to provide essential medical care to mothers. One of my friends in a state with abortion rights just miscarried between 6 and 9 weeks and received medical care immediately. She and her husband are now able to try again for a child because 1) she got her period back more quickly than if she didn't get medical care and 2) she's alive. Abortion access is critical if you want women to feel safe being pregnant. Please maintain legal abortion in the state of Missouri.

Madam Chair and members of the committee, thank you for allowing me to submit this testimony in opposition of HB 1667. My name is Jen Bernstein and I am the Director of Advocacy at National Council of Jewish Women St. Louis (NCJWSTL). NCJWSTL is a non-profit organization in metropolitan St. Louis, representing over 5,000 members and supporters throughout the state. We focus our work on community service, advocacy, education and philanthropy to improve the quality of life for women, children and families while supporting individual and civil rights, and have been doing so since 1895.

While HB 1667 is framed as a protection for infants, it is not grounded in medical reality. A future that did not include raising a child, most likely as a single mother working a minimum wage job without affordable child care and without support from the male politicians who would have liked to force me to have that baby.

Abortion was one of the best decisions I've made in my life but it is not a decision I took lightly as pro-lifers seem to imply. The most recent CDC data says that for the majority of women who had an abortion, it was the first time they ever had one.

The Amendment that voters passed in 2024 limits abortion after fetal viability (usually around 24 weeks), leaving the decision up to women and their doctors. And 93% of abortions occur during the first trimester (at or before 13 weeks) according to CDC data.

Pro-life arguments are rife with inaccuracies and assumptions that simply discredit women. I encourage you to do your research or speak to the women in your circle who have personal experience. They're there.

I'm now in my 30s with a successful career and a young daughter that I conceived by choice. I'm terrified that my daughter may face a similar situation as I did one day and not have the choices I had. We need to trust women to make the best choice for them, NOT politicians.



I am writing to submit testimony that with strong opposition to this bill.

Missouri law already recognizes infants born alive as legal persons, and both Missouri and Federal law already prohibit the intentional harm or killing of a live-born child. Health care providers are already ethically and legally required to provide appropriate care to any infant born alive, regardless of the circumstance of the birth. This bill does not fill a gap in "protection," but rather, has intentions of expanding criminal and civil liability in ways that are medically unnecessary and legally concerning. It mandates law-enforcement reporting in clinical settings, imposes severe criminal penalties for "perceived" failures in care, and creates expansive civil liability based on very vague standards such as negligence and recklessness. Such provisions risk interfering with medical judgment and may delay or discourage critical emergency care in complex and time sensitive cases. Additionally, the bill goes far beyond these "born-alive" scenarios by broadening liability related to self-managed abortion, medical assistance, and even speech or writing. These provisions raise serious concerns about constitutional protections, patient privacy, and the criminalization of individuals seeking or supporting health care during medical crises. I have been educating fellow constituents about the impositions that this bill hinders, and have received feedback from both republicans and democrats about the disappointment and disgust that they feel about politicians breaching their privacy and constitutional rights.

Policies that insert criminal law enforcement into medical decision-making undermine trust between patients and providers and create a dysfunction that harms both patients and providers. This bill risks punishing providers for outcomes beyond their control, rather than improving maternal mortality rates or neonatal health outcomes. If the goal is to serve Missouri Families, and to improve infant and maternal health, Missouri should focus on investing in evidence-based prenatal care, maternal health services, neonatal care access, and support for families, not by duplicating existing laws and expanding punitive measures that discourage providers from practicing in Missouri in a time when we need them most. Did you know Missouri continues to rank poorly on maternal health outcomes, rural hospital access, and provider retention? Policies that insert fear of prosecution into the exam room do not improve these poor rankings, they worsen them. This bill prioritizes punishment and political messaging over patient safety and sound public policy. For these reasons, I urge the committee to oppose this harmful legislation.

At its core, this bill substitutes statutory mandates and criminal penalties for medical judgment in some of the most complex and emotionally fraught situations in health care. While its stated intent is to protect infants born alive, existing state and federal law already recognizes that any child born alive is a legal person entitled to medical care. HB 1667 does not meaningfully add protections; instead, it introduces punitive enforcement mechanisms that undermine patient autonomy, clinician judgment, and the practice of evidence-based medicine.

HB 1667 requires health care providers to take specific actions under threat of criminal prosecution and civil liability, regardless of medical futility, prognosis, or parental wishes. Neonatal care at the margins of viability involves individualized, case-by-case decisions informed by gestational age, likelihood of survival, anticipated suffering, and family consent. This bill replaces that nuanced decision-making with rigid legal directives enforced by prosecutors rather than clinicians.

The bill's mandatory reporting requirements create a climate of surveillance within hospitals, compelling nurses, physicians, and staff to report one another to law enforcement or face criminal penalties themselves. This erodes trust within care teams, discourages open clinical discussion, and shifts decision-making authority away from medical professionals and families toward compliance and risk management departments.

HB 1667 also dramatically expands civil liability, allowing lawsuits based on negligence or disagreement over standards of care and eliminating traditional defenses such as consent or assumption of risk. This will incentivize defensive medicine and push providers toward maximum intervention regardless of medical benefit. The likely outcome is not better care, but prolonged suffering, increased use of invasive procedures, and higher costs with no corresponding improvement in outcomes.

For patients and families, this bill strips away meaningful autonomy during medical crises. Families facing catastrophic pregnancy complications may be forced into aggressive neonatal interventions even when comfort-focused, palliative care is the medically appropriate and humane option. The legislation disregards shared decision-making and imposes one-size-fits-all mandates on deeply personal and tragic circumstances.

Finally, HB 1667 lays groundwork for broader restrictions on abortion care by reframing abortion-related outcomes as presumptively criminal and expanding state oversight into private medical decisions. By shifting authority from physicians to courts and law enforcement, the bill establishes a

precedent that threatens access to comprehensive reproductive health care and discourages clinicians from practicing in this state.

For these reasons, HB 1667 risks harming patients, driving providers out of practice, and politicizing medical care without improving safety or outcomes. I urge lawmakers to oppose this bill and instead support policies that respect medical expertise, patient autonomy, and compassionate, evidence-based care.



This legislation is a tricky attempt to outlaw the majority of abortions as a part of the larger anti-abortion strategy to ultimately outlaw all abortions and make them impossible to access.

The American College of Obstetrics and Gynecologists opposes legislation that criminalizes self-managed abortion because the threat of prosecution, or legal action of any kind, puts people at further risk because they can scare people out of seeking critical emergency care when needed. Additionally, these policies have been found to disproportionately harm communities who are historically marginalized from care and are more likely to be reported and criminalized for their pregnancy outcomes due to bias and discrimination.

People criminalized or otherwise involved in the legal system for self-managed abortions, even if they are not charged or found guilty etc, are more likely to be ostracized in their communities, forced to move due to threats at their homes or inability to get or keep jobs. Additionally, this bounty hunter-esque legislation empowers abusers who would be further incentivized to invade the medical privacy of their victims and encouraged by the state to further isolate and monitor their private lives.

Medication abortion is safe, reliable, and popular. Since 2000, nearly 3 million people in the U.S. have had safe medication abortions that are facilitated by a medical professional. As of 2017, medication abortions account for approximately 60% of all eligible abortions in the United States. These bills are based on false claims, and have nothing to do with how abortion care works and how decisions about abortion care are made. Obstetrician-gynecologists, just like physicians in any other field of medicine, are dedicated to protecting, preserving, and promoting the health of their patients.

These bills are redundant and inflammatory- infanticide is a crime both federally and here in Missouri. This bill doesn't actually have anything to do with infanticide or abortion care. This bill only impacts grieving parents,families, and their care providers.

In reality, the consequence of these bills cruelly strips grieving parents' ability to make decisions with their doctors about palliative/ compassionate care that is best for their family and their faith. When parents experience tragedy like pregnancy loss, these kinds of bills rob them of the ability to choose to spend their child's final moments with them. Infants with a few moments, hours, or days to live would be taken out of the arms of their parents, hooked up to machines, and forced through painful and unnecessary medical procedures that prolong suffering. Perinatal palliative care refers to a coordinated care strategy that comprises options for obstetric and newborn care that include a focus

on maximizing quality of life and comfort for newborns with a variety of conditions considered to be life-limiting in early infancy. If this becomes law, parents and doctors will have absolutely no say in how the last few minutes or hours of their child's life will be spent.

Missourians already voted to kick politicians and government OUT of personal medical decision-making when a majority voted to legalize abortion and establish a Right to Reproductive Freedom. If the will of Missouri voters mattered to this committee, or if this committee was required to vote in alignment with the votes of their district, this legislation would not advance out of this committee because a majority (9 of 17) of districts represented just voted to legalize abortion and establish reproductive freedom protections.

Planned Parenthood Great Plains Votes (PPGPV) opposes HB 2294 and HB 1667, which in action would unconstitutionally ban abortion for some patients in the state and criminalize individuals who assist a pregnant person in obtaining an abortion. These bills, referred to as the “Born-Alive Abortion Survivors Protection Act,” are disingenuous in nature as they criminalize the provision of necessary medical care and further politicize abortion using false rhetoric and inflammatory language without any basis in science or reality.

“Born alive” rhetoric suggests that abortions involve delivering an infant and then choosing whether it lives a description based more in messaging than in reality. In real clinical practice, abortion is planned and performed intentionally to avoid suffering, consistent with medical ethics. Abortions later in pregnancy are found to occur when a patient has learned something about their pregnancy that’s made it no longer desirable, such as the emergence of a serious health issue to the fetus or the pregnant person, or experiences barriers to abortion services earlier in the pregnancy that force them to delay getting care.¹ The law cannot account for every potential complication in pregnancy. It should not interfere with a provider’s ability to give care that is necessary, compassionate, and appropriate, especially under complex circumstances.

These bills inject politicians directly into the patient-provider relationship, disregarding providers’ training and professional judgment, and undermining their ability to determine and provide the best course of care for their patients. Providers are already licensed and regulated under rigorous standards of care, subject to professional oversight and discipline, and accountable under existing laws governing child abuse, medical neglect, and medical malpractice that apply to every clinician and every patient in Missouri.

If codified, these bills would create a private right of action allowing individuals with familial ties to the fetus to sue abortion providers and pregnant people who obtain abortions for personal injury, bodily injury, or wrongful death. This has far-reaching implications as it would allow people to attack providers and provide a new avenue to attack a pregnant person for exercising their right to reproductive freedom. It also enables abusive partners to harass and surveil their victims. Each year, approximately 500,000 women are physically assaulted or raped by an intimate partner and three out of 10 women in their lifetimes are stalked, physically assaulted, or raped by an intimate partner.² Missouri should be protecting people who can get pregnant from violence or coercion, not exposing them to further harm by allowing others to weaponize the courts to control their bodies and reproductive

decisions.

In November 2024, Missourians voted to ensure that the “right to reproductive freedom shall not be denied, interfered with, delayed, or otherwise restricted.” This constitutional amendment, known as Amendment 3, would override the provisions of these bills if they were to become law, as the highest legal authority in the state.

For these reasons, we firmly urge the Committee to hold or vote against bills HB 2294 and HB 1667.

Missouri voters clearly supported abortion rights when they passed Amendment 3 in 2024. Since then, lawmakers have repeatedly attempted to undo that decision, including by passing House Joint Resolution 73 the following year to repeal those protections. House Bill 1667 fits into that same pattern and reflects a continued effort to override the will of voters rather than respect it.

This bill also addresses a problem that largely does not exist. Cases where a fetus survives an abortion attempt are extremely rare, especially within the timeframes that were protected under Amendment 3. Missouri law already treats infants born alive as legally protected persons under the Infant's Protection Act, RSMo § 565.300, which makes it a crime to cause the death of a living infant. There is no gap in the law that requires this bill.

What HB 1667 actually does is punish medical professionals who are helping patients through some of the most difficult moments of their lives. It creates fear and legal risk for doctors who should be focused on patient care, not on avoiding criminal charges.

This issue is personal for me. My wife has a medical condition that makes pregnancy and childbirth more dangerous. We hope to have children someday, and I would never want a doctor to hesitate in an emergency because they are afraid of legal consequences instead of prioritizing my wife's health and safety.

Lawmakers often claim to support individual liberty and limited government, yet this bill interferes directly in deeply private decisions that should remain between a patient and their doctor. For these reasons, I strongly oppose House Bill 1667.

I'm a stay-at-home mom of two.

Before I got pregnant with my first baby, I suffered a spontaneous abortion - or as some like to call it, a miscarriage. If these proposed bills were to pass, not only would I have had a potentially hard time finding medical care after this horrible trauma took place (with doctors potentially blaming ME as a possible culprit for the miscarriage), but one of the doctors who would have had a tough time administering my care **WOULD HAVE BEEN MY OWN FATHER** - the future grandfather of the fetus. Both myself and possibly my father could be ones questioned for the legality of the miscarriage - during one of the most mentally, physically and emotionally devastating times of my life. Would other doctors have hesitated to administer care for me? Would he have hesitated? Would I be questioned for the **MURDER** of what I thought to be my future child?

Almost every woman I know has either experienced a miscarriage, or knows someone who has. It's one of the most horrific times of life for a woman to go through. To be questioned and/or legally charged with harming your own unborn child is beyond cruel. Some might even call it evil.

Also, I know there are parts of these bills that deny a woman the right to hold her child after choosing to have an abortion due to medical need. Imagine going through the worst days of your life, only to be denied that form of comfort and closure. It's heartbreaking. It's wrong. It isn't helping push your cause.

Abortion care should be between a woman and her physicians and clinicians, using their best medical advice only. Women need healthcare at all points and in all points of inception, pregnancy and postpartum.

I oppose HB 1667.

The protection of children born alive is already a matter of settled law and shared moral consensus. No reasonable person disputes that a liveborn child is entitled to care, dignity, and legal protection.

HB 1667 does not clarify an existing gap in protection. Instead, it layers expansive mandates, reporting obligations, and civil penalties onto an area of medicine that already operates under strict professional, ethical, and legal standards. In doing so, it risks replacing clinical judgment with fear of punishment and transforming emergency medical settings into environments of surveillance rather than care.

The bill compels specific medical actions without clear allowance for individualized clinical judgment, expands civil liability while stripping long-recognized defenses, and incentivizes litigation over clarity. Laws that protect life should not do so by eroding due process, professional discretion, or proportionality.

Good law is careful law. When the state asserts moral authority, it must also demonstrate restraint.

HB 1667 goes beyond what is necessary to protect life and, in doing so, undermines the balance that justice requires.

Committee Inquiries Regarding HB 1667

Existing Statutory Framework

Please identify the specific provisions of current Missouri law that are insufficient to protect a child born alive during or after an abortion, and explain how HB 1667 remedies those deficiencies.

Factual Basis for the Legislation

Has an impact analysis been conducted regarding how HB 1667 may affect provider decision-making, emergency care protocols, or the availability of physicians in high-risk or underserved medical settings?

Redundancy Versus Clarification

If the bill’s intent is to reaffirm the legal status of a liveborn child, why is broad enforcement and penalty language necessary rather than a clarifying or declaratory amendment?

I oppose HB 1908.

The bill rightly acknowledges that pregnancy should not prevent a court from entering a judgment of dissolution of marriage or legal separation. That principle reflects basic fairness and deserves careful handling.

At the same time, the bill requires disclosure of pregnancy status while stating that pregnancy has no legal effect on the judgment itself. When a fact carries no legal consequence, the state should pause before compelling its disclosure—particularly when that disclosure involves sensitive, protected medical information. Justice is not served when privacy is surrendered without necessity.

The bill also relies on gendered language that no longer reflects the families our courts already serve, and it removes all existing defenses to divorce and legal separation without preserving limited judicial discretion for extraordinary circumstances involving coercion or abuse of process.

HB 1908 identifies a real concern. The question before this body is whether it resolves that concern with the restraint, precision, and respect for individual dignity that justice requires.
