I strongly support House Bill 1818, which establishes critical protections for minors engaged in content creation on social media platforms. In today's digital economy, more families and children participate in creating online content, often generating significant revenue and public visibility. However, existing laws have not kept pace with this transformation, leaving minors vulnerable to financial exploitation, privacy violations, and exposure to harmful material.

HB 1818 implements sensible and necessary safeguards. It requires content creators who feature minors to set aside a portion of earnings in a trust account for the benefit of the minor, ensuring that these young individuals receive their fair share of compensation when they reach adulthood. This provision upholds the principle, long recognized in entertainment and child labor laws, that minors' earnings should be protected from misuse.

The bill also empowers minors who have appeared in monetized content. After they turn eighteen, or if emancipated, individuals may request removal or editing of posts that feature them as minors, granting them meaningful control over their personal images and online history. This right to request removal is extraordinarily important in protecting the dignity and future opportunities of young people who may not have foreseen the long-term implications of digital exposure.

Additionally, HB 1818 imposes clear recordkeeping duties, mandates strategies to prevent the monetization of restricted or explicit material involving minors, and strengthens the roles of both content creators and platforms in protecting child safety. These requirements are not just good policy—they are essential in a rapidly changing digital landscape rife with potential for harm.

In sum, House Bill 1818 brings Missouri law up to date with current realities, while maintaining a strong focus on child welfare, privacy, and fair economic treatment. I urge lawmakers to support this bill and take a significant step toward protecting Missouri's children in the digital age.
