As a local Missouri actor, I have seen this benefit in action. In 2009, I was cast in Up In The Air with George Clooney. I worked on set for a week, which was a creative dream come true as an actor. I then received the biggest paycheck I had ever acquired for acting work to date. I received approximately \$20,000 for one weeks' work on a film in one role. I continue to receive royalties checks on a lower scale and that film was over fifteen years ago. Besides my own financial benefit; I witnessed St. Louis experience the excitement of a Hollywood film being produced here as well as a boost to the economy. Hotels were booked out and restaurants were filled with people excited to see any glimpse of George Clooney. Production staff went out into our city to dine and sightsee. I had a humorous conversation with Danny McBride about his first experience with provel cheese and how that was unique to St. Louis. All of this energy and financial support came from one movie; one production over a few months time. Imagine the possibilities our cities and State of Missouri could experience with additional productions brought here. As a local actor, it would be ideal to work in my hometown rather than travel for work. I will follow my dream wherever I need to to pursue that work... but it would be so amazing to see our city and state improve financially because of the potential that production would bring here. As a Missouri parent whose daughter, Jillian Depke, recently worked on a feature film shot, Soul on Fire, in St. Louis, I have seen firsthand how Missouri’s film tax incentive creates real opportunity for families and local communities.

This was her first official experience on a professional film set. Because the production was here in Missouri, she was able to participate in a one-day shoot with no travel costs and kept school absences to a minimum. She appeared multiple times in the film and was included in promotional materials. That experience made her dream of becoming a professional actress feel possible — without leaving the Midwest. When the film was released, it also garnered a lot of support and revenue at local theaters again boosting the economy in our hometown.

Years ago, I also worked as an extra on a major motion picture, Up in the Air, and filmed in our region and witnessed the economic ripple effect productions bring — supporting local crew members, drivers, restaurants, hotels, and small businesses. I was a homemaker at the time and got to make a little extra income by doing it!

HB2058 and HB2142 would strengthen the SHOW MO Act by combining the two \$8 million funding buckets (film and episodic) into one \$16 million fund. This does not increase the cap, but it allows Missouri to use the full incentive more effectively and avoid turning away projects when one category reaches its limit.

Extending the sunset from 2029 to 2035 is equally important. This does not remove the sunset — it simply provides stability and signals to producers that Missouri is a reliable place to invest, helping us stay competitive with the 37 other states offering incentives.

These bills support workforce development, small businesses, and young talent who want to build careers here at home.

Subject: Support for Strengthening Missouri’s Film Tax Credit Program

Dear Members of the Missouri Senate and House of Representatives,

I am writing to express my strong support for extending Missouri’s film tax credit program and for combining the current funding pools into a single, more flexible incentive structure.

As President of Coolfire Studios, a Missouri-based production and post-production company, I have worked directly within the framework of the state’s incentive program. Our experience has shown that Missouri’s film tax credit is not simply a tool for attracting feature films, it is a powerful economic development engine that brings new business, new spending, and new jobs into our state.

Missouri is uniquely positioned in the Midwest because its incentive program applies not only to traditional film and television projects, but also to commercial production and post-production work. This is a critical distinction. Neighboring states such as Ohio and Kentucky offer robust film incentives, but their programs do not extend to commercials or post-production. Missouri’s does.

This difference matters.

While attracting large-scale feature films is valuable, the day-to-day sustainability of our workforce depends heavily on commercial and branded content production. Today, marketing budgets are shrinking while production costs, including crew rates, continue to rise. As a result, it is no longer sufficient to rely solely on work originating within Missouri. To remain competitive and to sustain our creative workforce, we must actively attract projects from outside the state.

Missouri’s incentive is already helping us do exactly that. Just two days ago, I was in Cincinnati and Louisville pitching our services to national brands. When I shared that Missouri offers tax credits that can be used to help fund the production of their projects, there was immediate interest. This opens the door to pursuing work from companies such as Procter & Gamble and Kroger, organizations that would not otherwise be spending marketing dollars in our state. When these projects come to Missouri, they bring meaningful economic activity: hiring local crew, utilizing local vendors, booking hotels, renting equipment, engaging transportation services, and supporting a wide range of small businesses and community partners.

Coolfire is actively leveraging this program today. Over the course of 2024 and 2025, we have

submitted 17 tax credit applications for commercial and branded entertainment projects across Missouri. Each has been strategically used to help meet the needs of the project while keeping production dollars, talent, and opportunity within the state.

We participate in the Missouri Film Tax Credit program for several key reasons:

First, it helps offset rising costs in a changing market. Production and post-production costs continue to climb while client budgets move in the opposite direction. For a mid-sized independent studio like ours, access to tax incentives is a critical tool that allows us to stay competitive without compromising quality or creativity.

Second, it helps develop Missouri's film workforce. Through consistent production activity, we are able to train and employ emerging crew members, strengthening the local talent pool and increasing Missouri's ability to attract outside work.

Third, the availability of tax credits has become a decisive factor in winning and retaining projects. Within the past 6 months alone, three projects that were initially slated to film in other states were ultimately secured and produced in Missouri because of this incentive, creating immediate local economic impact. (Alabama, Indiana, Wisconsin)

Finally, the credit can support project financing and creative ambition. In certain cases, it allows us to bridge gaps between available budgets and the creative scope required to produce nationally competitive work, ensuring that high-quality content continues to be made here at home.

Equally important is post-production. When projects remain in Missouri for editing, animation, sound design, and finishing, the economic impact extends far beyond the shoot itself. These are high-skill, high-wage jobs that help sustain long-term industry growth.

Combining the two funding pools would make Missouri's program more flexible and more competitive. It would allow the state to respond to real-world demand, whether that demand comes from feature films, documentaries, or commercial production, without artificial limitations.

Ultimately, tax credit programs are intended to stimulate economic activity that would not otherwise occur. Missouri's program is doing exactly that, bringing new dollars into our state rather than redistributing existing ones.

By leveraging this incentive responsibly, Coolfire is not only sustaining its own growth but also contributing to the expansion of Missouri's broader film ecosystem, cultivating jobs, attracting new business, and positioning our state as a leading hub for commercial and entertainment production in the Midwest.

Thank you for your leadership and your commitment to growing Missouri's economy.

Having lived in both New York & Los Angeles prior to relocating to Saint Louis, I can tell you how impactful having a tax incentive for film & television is for not just the local workforce, but for the state/cities/towns as a whole as well. Productions don't just spend money on their own project when they shoot here, they spend money all throughout the town/cities/state. Restaurants, bars, coffee shops, attractions, shopping centers, hotels all see an uptick in business when productions come to town. And as a film and television worker, it used to be that you could only live in a city like New York, or LA, if you wanted to work in that field - but those places aren't always as conducive to raising a family like the midwest is, so being able to live here and raise our kids, while also being able to stay working in our industry, has been vital to us being able to be here in Missouri. And in order for larger productions to come here (and spend more money and hire more local workforce etc), combining the funds into one allows for MO to be considered on a larger scale show that would likely utilize more local resources, and need them for a longer period of time than a smaller production. It's also important to extend the sunset date, because if it is a television show for example, and they are planning for multiple seasons, they need to find a state where the incentive is not going to run out between seasons before they finish. Those types of shows are literally looking for states with longer term stability in terms of their incentives. I've never been a part of any production that has negatively affected the area it was filmed in, it only enhanced them positively, so there is literally zero reason to not extend the incentive or set it up in a way for even greater success than what we've experience thus far. It would actually be a mistake not to - film and television isn't going anywhere, and if we don't stay complete in terms of the incentives, another state will, and productions will go there instead and we will watch those jobs get taken, and money spent, by another place when we could've absolutely kept everything here.

As a worker who has been in the film/video industry here in St. Louis, MO for 15+ years I am in support of the tax credit. When the tax credit went away in 2013 the level of work dropped in the state making it difficult to be able to work only in the film industry. Since the tax credit has returned there has been an influx of work but not to the level seen prior to losing the tax credit. Another consequence of the tax credit going away in 2013 meant the St. Louis area lost a lot of experienced workers leaving for other states with a tax credit. Currently I am unable to support myself on just video production work currently as there are not enough large film/video production jobs coming in from out of town and most of the production work in St. Louis are commercial shoots, which usually are only 1-3 days vs 30-60 days for a motion picture or 2-3 months for TV shows. Please consider passing this bill to make Missouri more competitive with other states and hopefully keeping us from losing work to other states. The show "Tulsa King" was originally set in Kansas City but since we didn't have any tax credits the production went to Oklahoma instead. Bummer.

I work in the Missouri production community. I am a Casting Director, and Film In Mo Board Member and based in St. Louis, Mo. I work in Missouri's production community as an Assistant Professor of film, visual effects supervisor, director, and writer, and I'm writing to voice my strong support for HB2058 and HB2142.

Right now, our film incentive is split into two separate \$8 million buckets. One for TV series and one for film. This made sense years ago, but the industry has changed. We're seeing more feature films come through Missouri now, and this rigid separation is actually holding us back. Once we hit that \$8 million cap for film projects, we have to turn away work—even when there's money sitting unused in the TV bucket. That means lost jobs for local crew members and missed revenue for our vendors who count on this business to keep their doors open.

Merging these funds into one unified pool would give us the flexibility to say yes to more projects, whether they're films or series. It's a practical fix that would help us compete for the work that's actually out there.

I'm also asking you to support extending the sunset date from 2029 to 2035. We're not trying to make this permanent—just asking for a longer runway. When producers are deciding where to shoot, a tax credit that expires in three years doesn't inspire confidence. They need to know Missouri is serious about supporting this industry long-term. With 37 other states offering similar incentives, many with no sunset at all, we need to show we're in this for the long haul.

These changes would keep Missouri competitive and help our local film community continue to grow. Please support HB2058 and HB2142.

I've seen firsthand how Missouri's film tax incentive can work. I served as Visual Effects Supervisor on *Chasing Summer*, a feature film that shot here and utilized the tax credit. Our Missouri-made film premiered at the prestigious Sundance Film Festival last month. That project was a great example of what's possible when we can actually secure work in our home state. A few of my students even had the wonderful opportunity to work on set.

These bills aim to retain talent like me and so many others here in Missouri, support training for future filmmakers, and develop a sustainable production industry, rather than losing work to states with more conducive incentives.

It is increasingly evident that consolidating the current incentive allocations — \$8 million designated for television series and \$8 million for feature films — into one flexible fund would better serve Missouri. I am part of the Missouri film, television, and media production community as a producer, investor, and public policy advocate. I am writing to share that I am strongly in favor of the passage of HB2058 and HB2142.

The current tax incentive structure for film and television production was a great start, but it's not as efficient, effective, or easy to use as it could be. By combining the \$8 million for television and \$8 million for film allocations into one cohesive fund, we can eliminate some artificial barriers that may force us to turn away production business. The current structure may simply stall growth. Even when total funds are available, the industry may lose projects because one specific "silo" is exhausted. Moreover, the broader industry may regard the current division as unnecessary and too complicated vs. other states and markets. Unifying these funds will maximize our capacity to land high-impact production projects and fuel growth for local crews and local economies alike.

Additionally, extending the sunset provision to 2035 is essential for market confidence and more expansion in investment. Though it may be beneficial to compete with other states and jurisdictions, we are not seeking an indefinite extension, but rather the long-term predictability necessary to secure major investments. The overall industry and its producers look for stability when selecting filming locations, and a 2035 horizon keeps Missouri competitive against the many other states and countries currently vying for this business.

These adjustments are strategic moves to ensure Missouri remains a top-tier destination for film and television production. I urge you to support these bills to drive measurable economic outcomes for our local economies and our state.

I work in the Missouri Film and Television Production community as a producer and entertainment attorney, and I strongly support HB2058 and HB2142.

I have seen first-hand the positive impact the Missouri Motion Media Tax Incentive program has had on our industry over the past two years – both in increasing jobs and spending in the state, but also in how Missouri is viewed nation-wide. I have been directly involved with television pilot episodes as well as feature films whose key producers chose to come to Missouri primarily because of our tax credit program, and they have had a great experience here not only because of the tax credit, but also because of the strong production crews and overall supportive community they find in Missouri. The word is getting out that this is a great place to film!

As strong as our tax credit program currently is, it can and should be improved to increase the job creation and investment our state needs. Both of these bills do just that.

First, combining the tax incentive amounts (currently \$8 million for TV Series & \$8 million for Film) into one cohesive \$16 million fund will be in the best interest of Missouri. The current structure can steer some projects away from Missouri because of uncertainty whether there will be enough room under the current caps in each category, while combining the funds will allow us to land more projects in both film and TV. For example, once the current \$8 million for Film is allocated, we cannot accept new film business in that year even if there are available funds in the TV series portion that are not being utilized. This unnecessarily limits job opportunities for Missouri citizens and hampers Missouri vendors who rely on production business to thrive.

In addition, I strongly support extending the sunset from the current 2029 expiration to 2035. We are NOT asking for the sunset to be removed, just extended. This is very important because of the message it sends to potential investors in longer-term projects such as construction of production studios and investment in major production equipment. It incentivizes this type of investment in our future because the program that supports the underlying production business will last long enough to generate a meaningful return on that investment. It also keeps us competitive with the 37 other states that offer film production incentives.

I am proud to talk about the Missouri Motion Media Tax Incentive program whenever I speak to producers around the country – but it is crucial that we adapt our funding approach to ensure that Missouri remains a competitive player in the film industry for years to come. The jobs and positive impact are real.

I am a Missouri-based filmmaker, television producer and independent studio founder. I strongly support HB2058 and HB2142.

As written, these bills improve the existing SHOW MO Act by allowing the current \$16 million cap to function as a single, flexible fund rather than two separate \$8 million buckets for film and episodic television. This change does not increase the cap. It simply allows the program to operate more efficiently in response to actual market demand.

In practical terms, combining the funds removes an artificial barrier that can prevent Missouri from landing projects even when incentive dollars remain available. If the film allocation is exhausted while episodic funds sit unused, producers look elsewhere. That means lost jobs for Missouri crew members, lost revenue for local vendors, and lost economic activity in our communities. This bill corrects that inefficiency.

Equally important is extending the sunset from 2029 to 2035. The film and television industry operates on long development timelines. Producers and investors evaluate states based on stability and predictability. A short runway creates hesitation. Extending the sunset, without removing it, signals that Missouri is serious about competing with the 37 other states that offer production incentives. TO THE HONORABLE MEMBERS OF THE COMMITTEE

Thank you for the opportunity to testify. My name is Elias Tsapelas, and I'm the Director of State Budget and Fiscal Policy at the Show-Me Institute, a nonprofit, nonpartisan, Missouri-based think tank that advances sensible, well-researched, free-market solutions to state and local policy issues. The ideas presented here are my own and are offered in consideration of proposals that will affect tax credits in Missouri.

House Bill 2058 consolidates Missouri's existing film and series production tax credit sub-caps into a single \$16 million pool for both, leaving the state's total commitment the same. The only substantive effect of the bill would be to give the Film Office more flexibility in how the same dollars are allocated. That flexibility does not address the fundamental problem with this program.

Current and Past Tax Credit Failures

Despite the Missouri film tax credit's recent revival, our state has a long history with this troubled incentive. Until its sunset in 2013, Missouri's previous iteration made promises similar to what supporters are touting today. Missouri's own Tax Credit Review Commission recommended the credit be eliminated because it served too narrow an industry and failed to provide a positive return on investment.

Research confirms that pattern holds nationally. Film tax credits have not resulted in job growth, have not affected market share or industry output, and have produced only short-term wage gains for those already in the industry. Credits in many states generated just cents on the dollar. As one Tax Foundation analyst notes, "non-favored activities and businesses remain on the hook to bear the full impact of the state's tax code."

The Missouri Film Office has pointed to the number of projects approved and production spending in the state as evidence the program is working, but that is not the right measure for determining whether the program is a good investment for state taxpayers. The relevant question is how much the state receives back in tax revenue and broader economic activity—and by that measure, the research is consistent: film tax credits do not generate a positive return.

The Competitiveness Argument Doesn't Hold

Supporters of HB 2058 argue that pooling the sub-caps will make Missouri more competitive for productions. Even setting aside the ROI question, that argument doesn't hold.

Steven Conrad, the showrunner who created a new HBO series set in St. Louis and filmed it entirely in Atlanta, recently suggested that governments may not be well-served by chasing the film industry at

all. His observation reflects a structural reality: Georgia has spent two decades building the studios, crews, soundstages, and production infrastructure that make large productions possible. Missouri has not. No reallocation of \$16 million changes that.

Georgia's own state auditor found that even Georgia's fully developed, deeply established program returned just 10 cents to the state for every dollar of credit granted, producing a net revenue loss of \$602 million in a single year. If one of the most mature film-incentive programs in the country cannot generate a positive return on investment, a program at a fraction of its scale operating in a state without comparable infrastructure has no prospect of doing so.

Targeted Credits Are Poor Economic Policy

Targeted economic development tax credits are just another way for lawmakers to pick winners and losers, a job that is better left to consumers in the market. When tax breaks are given to some, other taxpayers have to make up for the lost revenue. The impulse to do something to support an industry is understandable, but tax credits are a poor substitute for the conditions that make industries thrive organically. A dollar of film tax credits reduces state revenue by exactly the same amount as a dollar of direct appropriations — the difference is that credits bypass the appropriations process and receive less scrutiny.

Prioritize Tax Relief That Benefits All Missourians

Missouri is already a national leader in state spending in the name of economic development. Over the past few decades, Missouri has forgone billions in state tax revenue in favor of a host of narrow incentives that have consistently shown poor results. In FY2025 alone, Missouri redeemed more than \$961 million in tax credits—nearly double the \$521 million redeemed in 2010. The General Assembly is simultaneously weighing whether to eliminate the state income tax, a reform that would deliver broad economic benefits to every Missourian. The legislature should consider whether a growing tax credit portfolio is consistent with that goal. Expanding targeted credits that erode the income-tax base works against broad-based tax relief, and Missouri would be better served by pursuing the latter.

The film tax credit is a small program, but it exemplifies the approach to tax policy that makes comprehensive reform harder to achieve. Tax credit programs have not been successful in Missouri in the past, there is little evidence to suggest the film tax credit is succeeding now, and there is no reason to believe this program will perform differently under a restructured allocation. If increasing economic opportunity is the goal, the research is clear: Instead trying to manufacture more opportunities at the expense of taxpayers, lawmakers should provide broad-based tax relief to every Missourian.

This notice is submitted to formally place the General Assembly on record regarding foreseeable constitutional, fiscal, and structural risks associated with HB 2058’s expansion and extension of transferable motion media production tax credits.

Public Purpose Requirement (Mo. Const. Art. III, § 38(a))

Tax credits represent foregone public revenue and function as public expenditures. Expanding a targeted, transferable credit program for a specific private industry without updated, evidence-based findings demonstrating a primary public purpose may invite scrutiny if the dominant effect is private enrichment rather than statewide economic necessity.

Special Law Concerns (Mo. Const. Art. III, § 40)

HB 2058 confers preferential tax treatment on a defined class of motion media production entities. If the classification lacks a demonstrable, rational statewide basis distinct from industry favoritism, the measure may implicate Missouri’s prohibition on special laws.

Equal Protection Considerations (U.S. Const. amend. XIV; Mo. Const. Art. I, § 2)

While tax classifications are afforded deference under rational basis review, expanding transferable credits and increasing annual caps without updated fiscal justification heightens litigation risk where similarly situated industries receive no comparable treatment.

Transferability and Monetization Risk

The authorization to sell, assign, or otherwise transfer credits effectively converts the credit into a tradable financial instrument. This structure weakens the nexus between in-state economic activity and the tax benefit received, amplifying fiscal exposure beyond the original applicant.

Escalating Fiscal Exposure

Increasing the annual cap to \$16 million and extending the sunset to 2035 materially commits future legislatures to sustained revenue displacement absent mandatory performance audits, net-revenue triggers, or clawback strengthening provisions.

Interstate Incentive Competition Clause

The provision conditioning termination upon nationwide cessation of similar programs effectively acknowledges participation in an interstate subsidy competition. This structural dependence raises prudential concerns regarding long-term fiscal sustainability and competitive escalation.

This notice reflects foreseeable constitutional and fiscal vulnerabilities under Missouri law and established equal-protection doctrine.

Members are hereby on formal notice that expansion and extension of this transferable credit program, without strengthened accountability measures and updated legislative findings, may invite judicial scrutiny and long-term budgetary consequence.
