Mr. Chairman and members of the committee, thank you for allowing me to submit testimony in support House Bill 2302. My name is Amy Kuo Hammerman and I am the Missouri State Policy Advocate for National Council of Jewish Women, based in St. Louis (NCJWSTL). NCJWSTL is a non-profit organization in metropolitan St. Louis, representing over 5,000 members and supporters throughout the state. We focus our work on community service, advocacy, education and philanthropy to improve the quality of life for women, children and families while supporting individual and civil rights, and have been doing so since 1895.

NCJWSTL supports the enactment of comprehensive, humane, and equitable criminal legal reform and works to promote and protect the right to vote. Our goal is for every eligible voter to be able to cast a ballot and engage in all levels of government in a meaningful way - including those who have paid their debt to society through the criminal legal system. HB 2302 would provide humane treatment and dignity for former inmates and increase access to the ballot in an important way. Requiring the Department of Corrections to coordinate with the Department of Revenue to provide state-issued identification to inmates will assist in obtaining post-release employment and access to registration for the vote as allowed by law. Both of these objectives increase dignity and well-being of former inmates and makes for a stronger democracy.

We urge you to vote YES on HB 2302.


Members of the committee. My name is Amy Rulo. I am the wife of a former incarcerated individual who served 17 years in Missouri Department of Corrections facilities and is on his 3rd year of parole. I would like to submit testimony in support of House Bill 2302 and address some of the issues a newly released individual faces that should be considered when perfecting the bill.

Any money they have is put on a JPay debit card. JPay puts a hold on the payments so the actual amount doesn't go through for days. \$150 of my husband's funds are still stuck somewhere in their system. Using debit cards, banking, cell phones, gas pumps, the internet, and so many other things commonly used now are things someone locked up for many years will not have any experience with. Instruction on these items would be highly beneficial.

When someone walks out of those doors they should have their birth certificate, social security card, non-driver's license photo ID, and the Substance Awareness Traffic Offender Program (SATOP) completed if they have lost their driver's license due to DWIs. The cost of the SATOP program alone ranges anywhere from \$500 to \$2000 depending on the level they are assigned to. An ID costs \$12 plus fees for 3 years, \$18 plus fees for 6 years, and \$18 plus fees for individuals 70 years or older with no expiration. Monthly Intervention Fees for parole are \$30 per month beginning as soon as they walk out. If my husband had not had my home to come to and my income to help him acquire these items he would not have been able to seek or get employment. He would not have been able to get to his required parole visits.

Other factors that severely impede their path to reentry are landlords not wanting to rent to them, employers not wanting to hire them and lack of health insurance which leads to the inability to get the medical/and or mental health care they need.

In conclusion I would like to ask you to please look over all of the needs for these individuals very carefully and put yourselves in that position. Our communities will be a better place if incarcerated individuals come back to society with as many required items as possible already provided for them so they can make every effort to get started in living honest, productive lives.

Chairman Mayhew, Vice-Chair Cook, Ranking Member Collins, and Members of the Committee, thank you for holding this hearing and for the opportunity to provide testimony.?

My name is Camellia Peterson, and I am the Legislative Director of Americans for Prosperity, Missouri. We urge you to support H.B. 2302, which would boost rehabilitation and reduce recidivism rates, thereby protecting the citizens of Missouri.

This legislation requires that upon the discharge of an incarcerated individual who intends to remain in the state, the Missouri Department of Corrections must provide them with a Missouri Identification card. Additionally, they will be provided with a Social Security card, a certified copy of their birth certificate, and relevant vocational training and work records. It also ensures that they are informed of their eligibility to apply for occupational licenses in the state of Missouri.

These measures will make the people of Missouri safer by reducing the factors that directly lead formerly incarcerated individuals to reoffend. The dignity and self-sufficiency provided by work, in addition to being a vital American value, has been shown to reduce crime rates, making law-abiding citizens significantly less likely to become victims of crime. Most people currently behind bars will eventually be released back into society. A well-functioning criminal justice system should reduce unnecessary barriers to successful reentry, such as a lack of proper identification.

While there has been commendable improvement in Missouri's recidivism rates, they are still far too high. The Missouri Department of Corrections reported that for individuals released from prison in 2021, nearly one in three reoffended within three years. In addition to the obvious tragic impacts of crime, the cost to re-incarcerate these individuals puts a strain on the state's finances.

A leading cause of recidivism is a lack of stable employment. Employment is significantly harder to find without documentation such as an ID, social security card, etc. The cost and confusion to obtain this documentation, while a minor issue for most citizens, may be too much for someone recently released from prison. Releasing prisoners without valid IDs creates easily removable barriers to their opportunities for success.

Lack of a valid ID also poses problems for acquiring stable housing. Recently incarcerated individuals

with limited funds and without the proper documentation are at an elevated risk of sleeping on the streets or of ending up staying in crime-ridden houses, all of which increases their likelihood of reoffending.

None of these measures will increase the chances of more Missourians becoming victims of crime. People should rightfully be held accountable for the crimes they commit; however, this legislation would affect only those who will be reentering society.

Criminal justice policy should look to the long-term safety of the state. A key aspect of reducing Missouri's recidivism rates is ensuring that our system is more effective at facilitating successful reentry.

Thank you for the opportunity to testify today.

My name is Clifton Davis, and I am here in strong support of House Bill 2302.

The Missouri Department of Corrections is about corrections.

The criminal justice system is about rehabilitation.

And rehabilitation is how we reduce recidivism, victimization, and long-term costs to the state.

HB 2302 is a rehabilitation bill.

This bill recognizes a simple but important truth: rehabilitation does not begin with grand gestures—it begins with small, practical steps. When we focus on the small things and get them right, we start putting the pieces together and create real, lasting outcomes.

One of those small things is identification.

When individuals are released from custody without a valid state ID, they immediately face barriers to lawful employment, housing, healthcare, transportation, and compliance with supervision. That lack of documentation becomes a roadblock to rehabilitation—and too often, a pathway back to incarceration.

HB 2302 removes that barrier.

By requiring the Department of Corrections to address identification before release, while the state still has custody and records, this bill aligns policy with purpose. It allows rehabilitation to continue beyond the prison gate instead of stopping at it.

This is how we reduce recidivism.

People who leave custody with proper documentation are more likely to work, more likely to stabilize their lives, and less likely to return to the system. When rehabilitation succeeds, future crimes are prevented, and future victims are spared.

That benefits everyone.

HB 2302 is also responsible governance. It does not expand bureaucracy or create new entitlements. It uses existing systems, existing records, and existing funding options to fix a preventable

problem—before it becomes a public-safety issue.

Members of the Committee, I do not believe anyone votes against rehabilitation. And if a missing state ID stands in the way of rehabilitation—and contributes to reincarceration—then removing that barrier is not controversial. It is common sense.

HB 2302 strengthens corrections, supports rehabilitation, reduces recidivism, and promotes safer communities.

I respectfully urge you to vote yes on House Bill 2302.

Dear members of the House Corrections and Public Institutions Committee:

The Missouri Voter Protection Coalition (MOVPC Action) submits this testimony in support of HB 2302, which would require the Department of Corrections to facilitate obtaining a state ID for those being released from the Department of Corrections. This is a valuable reform that will aid in multiple aspects of rehabilitation that help prevent recidivism, and promote good citizenship.

Among other things, a current (or recently expired) Missouri state ID is currently needed to vote. Returning citizens are among the populations least likely to have a valid and current state ID, both due to incarceration, but also to lack of access to underlying documents like a certified birth certificate, social security paperwork, etc.

This legislation addresses these barriers by allowing a Department of Corrections-issued record card as valid identification documentation for an inmate to obtain a state ID, and by allowing an ID obtained with a DOC record card to be valid up to four years. This will help returning citizens have the ID they need to obtain housing, employment — and vote — which will promote positive re-entry and good citizenship. This is particularly helpful as Missouri lawmakers consider legislation this year that would restore voting rights to returning citizens on probation and parole.

Voters of color are significantly disproportionately impacted. One in 19 African Americans of voting age is disenfranchised due to a felony - a rate 3.5 times that of non-African Americans. Among the adult African American population, 5.3 percent is disenfranchised compared to 1.5 percent of the adult non-African American population.

Peer-reviewed studies unilaterally confirm that voting after release from incarceration reduces recidivism. States that allow post-release voting have lower recidivism rates, and more positive re-entry experiences. Why? Voting encourages engagement and participation. It gives people a stake in their communities. This is one reason many states are moving towards restoring voting rights for those on probation and parole. Since 1997, 26 states and the District of Columbia have guaranteed voting rights to people living with felony convictions in their past. As a result, over 2 million Americans have regained their fundamental right to vote, and are contributing members of their communities. ?

By facilitating acceptable ID, HB 2302 helps the re-entry process and helps move people into

productive citizenship. Accordingly, we urge this committee to Support HB 2302.

Requires Dept of Corrections to coordinate with Dept of Revenue to provide a state ID to inmates without a current Missouri ID

Nine months prior to an inmate's release from custody, the Department of Corrections will determine whether the inmate has a current state ID and, if not, begin gathering the required documentation to receive one. A certified birth certificate and a Department of Corrections-issued record card will be valid identification documentation for an inmate to obtain a state ID.

State-issued ID cards issued with a record card from the Department of Corrections must be valid for a period of four years and are nonrenewable and nontransferable. The Department of Corrections can utilize any funds to cover the purchase of ID cards, including but not limited to, inmate trust funds, existing funds of the Department, and donations. The Department must provide an inmate with the types of documentation specified in the bill to assist in post-release employment.

As the largest and oldest anti-poverty non-profit in our state, Empower Missouri is committed to improving the quality of life for all Missouri residents through advocacy. Since our inception, Empower Missouri has focused on the criminal justice system and its impacts. Our Community Justice Coalition consists of community advocates and organizations from across the state who work with those who have been impacted by the criminal justice system. Many coalition members are formerly incarcerated or have currently incarcerated loved ones, and all are connected by a vision for a future without mass incarceration.

We are providing testimony today in support of HB 2302, sponsored by Representative Oehlerking, which would ensure that individuals leaving Missouri prisons have access to crucial documentation, as well as a host of other resources to help ensure successful reentry and employment outcomes. This bill outlines that the DOC will obtain the following for individuals preparing for release: a state ID, a certified copy of their birth certification, a Social Security card, a resume that includes any trades learned by the individual, a copy of their vocational training record, a copy of their work record, and documentation that they have completed a practice job interview.

According to the most recent available data from the Department of Corrections, Missouri's recidivism rate is 39%, meaning that nearly 4 in 10 people released from prison will end up returning to custody within 5 years. Supporting positive employment outcomes is one way that has been proven effective to reduce recidivism. Studies from the National Resource Council report that up to half of formerly incarcerated individuals remain unemployed for as long as a year after their release. Incarceration contributes to lower hourly wages and reduced annual earnings. Formerly incarcerated individuals typically hold low-paying, insecure jobs and experience frequent periods of unemployment and high job turnover. Supporting employment outcomes through vocational training and interview preparation, in addition to ensuring that individuals have the necessary documentation to hit the ground running upon release, will go a long way in helping people leaving Missouri prisons find stable and sustainable employment.

Empower Missouri urges this committee to take action to pass HB 2302 into law. Thank you for your time and consideration of this matter.

Dear Honorable Committee Members:

The ACLU of Missouri (ACLU-MO) submits this testimony in support of HB 2302, which standardizes the processes by which individuals leaving incarceration obtain essential personal documentation during their reintegration. The ACLU-MO is the state affiliate of the national ACLU and works in the courts, legislature, and Missouri communities to defend and preserve the civil rights of individual Missourians.

Identification documents such as state-issued identification cards, Social Security cards, and birth certificates are essential to accessing many of the facets of modern life. Applying for employment, registering to vote, obtaining healthcare benefits, and securing housing all require access to these important documents.

Importantly, this bill provides that Department of Corrections-issued identification may be used for obtaining a Department of Revenue-issued card. However, identification issued pursuant to this provision is only valid for four years following release from incarceration. See § 217.443.5. Because the underlying document is state-issued, we request that identification issued pursuant to this provision be valid for six years instead of four, which aligns with current expiration standards for state-issued identification. Here, there is no question about the identity of the incarcerated individual, there is no reason to limit the temporal validity of the issued card.

Minor adjustment aside, this bill is a positive step forward for those leaving incarceration. Accordingly, we urge you to vote YES on HB 2302.

For this reason we wish to support the proposed bill. We do have questions and believe there needs to be clarity and possible amendment to specify how the handling of individuals with shorter offenses such as a 120 treatment would be provided with ID prior to release. We would also ask to have additional steps taken to allow individuals a real opportunity towards gainful employment by extending Missouri's "Ban the Box" policy for state jobs from Governor Jay Nixon's Executive Order 16-04 to not be secluded to state employment applications, but statewide where individuals are afforded a real chance to succeed. We can offer all the job readiness and skills training in the world but until we allow those with records to be rightfully considered in the workforce it does very little to reach the end goal of reducing recidivism and allowing individuals to achieve success.



I am writing to urge your support for HB 2302. For the past 16 years, I have served as a Volunteer in Corrections, bringing the message of recovery to men at the Jefferson City Correctional Center and Algoa Correctional Center.

I have witnessed the transformation of lives of incarcerated individuals through the practice of the 12-steps. However, I have also witnessed the heartbreaking "revolving door" of our justice system. I have spoken with numerous men who were released with the best of intentions, only to find themselves back behind bars in less than a year.

When an individual is released, they are required to have a "home plan" covering housing, employment, and treatment. Yet, without a state-issued ID, executing that plan is nearly impossible. A state-issued ID is the "key" to the community; without it, they cannot legally work, secure housing, or open a bank account.

The transition back into society is jarring, especially for those who have been incarcerated for many years and are navigating a world that has changed technologically and socially. By ensuring an inmate has their documentation in hand upon release, HB 2302 removes a significant hurdle and allows them to focus on their recovery and employment immediately.

This bill is a common-sense step toward reducing recidivism and supporting successful re-entry. I respectfully ask the committee to vote "Do Pass" on HB 2302.
