Legislative Notice

The General Assembly is on notice that HB 3175 creates a disability-related designation within a statewide law enforcement intelligence database. Absent explicit statutory limitations on use, disclosure, and data protection, this structure raises foreseeable constitutional challenges under the ADA, Equal Protection Clause, and privacy jurisprudence. Any misuse or disparate enforcement resulting from such designation will predictably generate litigation exposure.
