Legislative Notice:

The General Assembly is placed on notice that HB 3205's undefined triggers—particularly “affiliated with” and “exercise any control”—paired with felony penalties and expansive civil remedies, create foreseeable due-process (vagueness/overbreadth) litigation risk, and that the bill's foreign-principal targeting raises predictable federal preemption and foreign-affairs conflict arguments.
