The General Assembly is hereby placed on notice that HB 3280, while largely a policy measure, authorizes the creation of state-issued identification that publicly discloses personal status related to marital history and association with disability. To the extent such disclosures are displayed through government-issued license plates, consideration should be given to whether participation remains fully voluntary and informed.

This testimony is submitted to document that potential privacy considerations associated with public disclosure were identified prior to enactment.
